

CAMPGROUND RULES

- All campers must be registered and fees paid before utilizing campground facilities. Reservations are not transferable and non-refundable. Reservations may only be made online (summitmetroparks.org) and in person at the Summit Metro Parks administrative offices (975 Treaty Line Rd., Akron 44313) during regular hours.
- Check-in time begins at 2 p.m. Camping reservations expire at 11 a.m. on the expiration date. All personal property must be removed from the campsite by this time. Any personal property left at campsites after expiration of the camping reservation is deemed to be abandoned and is subject to disposal by Summit Metro Parks.
- All personal property, including but not limited to trailers, camp shelters, camping equipment, and motor vehicles, left or stored on Summit Metro Parks property without the written permission of Summit Metro Parks shall be impounded and disposed of in accordance with Park Policies.
- Camping reservations must be affixed to the campsite marker.
- The individual whose name appears on the reservation as the applicant is responsible for all members of the group and must be present at the campsite. Persons under 18 years of age will not be issued camping reservations.
- You can stay up to 10 consecutive days during a 30-day period on any campsite.
- Campsites are limited to six persons per site. An exception may be made for single families whose immediate members exceed six people, with prior approval from Summit Metro Parks. Any persons not registered as campers are considered visitors and are not permitted to stay overnight.
- Camping is confined to the designated site. Brush clearing is prohibited.
- Pets (maximum two dogs per site) must be on leashes no longer than 8 feet and must not be left unattended. Vaccination records must be available on site.
- Campsites accommodate a tent or tents with combined floor space under 200 square feet, or a camper, RV or truck camper and a tent.
- All vehicles, RVs and trailers must be parked on your campsite's paved driveway. Driving or parking off road is not permitted. See site details for maximum length each site can accommodate. (This rule does not apply to Other Power Driven Mobility Devices as defined in 28 Code of Federal Regulations Part 35, Regulation Section 35.104 ["OPDMDs"], used by individuals with mobility disabilities for the purpose of locomotion.)
- Use of vehicles within the campground is limited to entering or leaving those areas. (This rule does not apply to OPDMDs used by individuals with mobility disabilities for the purpose of locomotion.)
- Alcohol is prohibited.
- Quiet hours are in effect from 10 p.m. to 6 a.m. daily. During quiet hours, noise-producing equipment should be turned off.
- The campground is a generator-free area. Generator use and battery charging by engine idling is also prohibited.
- A fire ring and picnic table are located at each site. Do not remove them.
- Obey any restrictions on fires. Fires may be limited or prohibited at certain times.
- All fires must be contained to the fire ring or self-contained grill, and must be attended at all times. Be certain your fire is completely extinguished upon departure. You are responsible for keeping fires under control. Burning or disposing of trash in campfires is prohibited.
- No gathering of firewood of any size or any type is permissible. Campers are responsible for firewood.
- Chainsaws, fireworks or other explosives and firearms are prohibited at all times, unless permitted by law. Persons possessing a valid firearms license issued in accordance with the Ohio Revised Code may carry a concealed firearm within the Park except inside any government building located in the Park that is not used primarily as a shelter, restroom, parking facility for motor vehicles or rest facility, and subject to any other restrictions imposed by law.
- Bring your own water. No drinking water is provided at this campground.
- Camper holding tanks may only be emptied into approved, designated facilities. The water faucet at the dump station is only to be used for cleaning out a camper's black/grey water tank.
- Trash and camp waste should be taken home or disposed of in the trash containers provided.
- Swimming is not allowed in Nimisila Reservoir.
- Electric motors are permitted on Nimisila Reservoir. Gasoline motors are prohibited.
- Summit Metro Parks personnel have the right to terminate a camping permit at any time for failure to follow campground rules, park rules, laws or unsafe behaviors.
- For your safety, be aware of the weather and always keep safety in mind.
- All other Rules and Regulations of Summit Metro Parks apply.
