### Economic Impact

A 2013 study conducted by The University of Akron and Lux Research, LLC revealed the park district's annual economic impact:

- Increase property values by nearly \$42 million
- Up to \$17 million in health benefits to residents
- Up to \$3 million in Summit County tourism

### **Improvements**

The following is a partial list of projects completed in 2013.

#### FIRESTONE METRO PARK | 44319

Removed old boardwalks, improved the shoreline and constructed a new T-dock for youth fishing at Little Turtle Pond



#### FREEDOM TRAIL | 4 miles

 Opened Phase I — between Middlebury Road and Tallmadge Circle — of this planned eight-mile trail that will connect Akron and Kent

#### FURNACE RUN METRO PARK | 44286

Installed new tile in Brushwood Pavilion

#### **GOODYEAR HEIGHTS METRO PARK | 44305**

 Planted trees, replaced cooking grills and made repairs to the Alder Trail boardwalk



# HAMPTON HILLS METRO PARK | 44223

• Opened a new public archery range with six shooting stations

#### F.A. SEIBERLING NATURE REALM | 44313

 Planted new trees and perennials, and installed a butterfly garden behind the visitors center

#### **MUNROE FALLS METRO PARK | 44262**

 Constructed a new boardwalk in the Lake Area, replaced the bathhouse roof and built a new open-air shelter in the Tallmadge Meadows Area



#### SAND RUN METRO PARK | 44313

Replaced windows in the 1930s-era Mingo Pavilion

#### SILVER CREEK METRO PARK | 44203

 Opened a new public archery range with six shooting stations and built a new footbridge on Chippewa Trail

#### OHIO & ERIE CANAL TOWPATH TRAIL | 22.4 miles

 Resurfaced several miles of the trail and installed 10 historic mileposts

#### **DISTRICT-WIDE**

 Completed boundary surveys and bridge inspections, installed new traffic counters, removed hazard trees and repaired storm damage

## Programs & Events

#### **EDUCATION**

Naturalists led 979 programs, teaching 32,338 visitors of all ages about environmental education, recreational activities and the park district's natural and cultural history.

Scouts earned badges and students met Ohio's science

standards through experiential learning in an outdoor setting.

More than 66,000 visitors learned about nature with educational exhibits, native live animals, events and naturalist interactions at

F.A. Seiberling Nature Realm. Gift shop sales increased by 32 percent.

#### SPECIAL EVENTS

In 2013, more than 2,000 visitors earned rewards during the 10th annual Spree For All hiking event (May-June) on flat, easy trails. More than 650 runners participated in the 2nd annual Mother's Day 5K at Munroe Falls. Nearly 1,000 riders completed the inaugural Summer Biking Spree (July-August) on multipurpose trails. More than 12,000 people earned rewards during the 50th annual Fall Hiking Spree (September-





November) on easy, moderate and difficult trails. Thousands of visitors enjoyed free hayrides and more at the **Fall Family Outings**, held at Goodyear Heights and Silver Creek in October.











## Resource Management

#### CITIZEN SCIENCE

 Established a new web-based program allowing visitors and volunteers to upload wildlife sightings on iNaturalist.org

#### **COYOTE RESEARCH**

 Concluded a three-year research project, made public presentations and published a short documentary on YouTube



#### STREAM RESTORATION

• Completed design and engineering for the continued restoration of Pond Brook in Liberty Park

# Safety & Security

- Rangers tallied 10,900 hours of foot patrols and 625 hours of bicycle patrols, resulting in more than 59,000 contacts with visitors.
- The Bike Patrol, which consists of more than 80 volunteers, rode the Bike & Hike and Towpath trails to offer assistance to visitors.
- Thirty-five lifeguards kept watch during the swim season at Munroe Falls and Silver Creek.

### Volunteers

More than 1,000 volunteers gave 32,422 service hours. Roles included support of customer service, resource management, interpretation, rangers and operations.
